Guidelines to fill up the application form for Hajj 2010

Note: To be filled in English only in BLOCK letters. The first leaflet of the form is to be filled by the Head of cover and the remaining forms have to be filled by other applicants, if any, in the cover, second applicant in the same cover has to fill up the “Co-applicant-2” form indicated at the right side of the form. Similarly third applicant has to fill up the “Co-applicant-3” form and so on. Infants details should be filled in Infant form.

PHOTOGRAPH: 3.5 x 3.5 cm passport size photograph should be taken with white background only. Affix (paste) one recent passport size photo on the application first page and the other one on the 2nd page of application.

1. Amount to be deposited in Account No.31136268352

Bank reference number : Fill the bank reference number mentioned by Hajj Committee of India in the Hajj pilgrims’ selection letter without fail.

Amount : Write the amount paid for your group members.

Name of the Branch : Write the branch name

Branch code no. : Write the branch code number

Receipt date : Write the date of remittance.

Note: The pay-in-slip enclosed in the last page of the application may be used for remittance of advance foreign exchange amount and furnish the above details without fail. The same details may also be written in the application form.

2. Accommodation status: Tick the desired accommodation category.

Green : Tick (/) off this column if you opt for Green category accommodation.

White : Tick (/) off this column if you opt for White category accommodation.

Azizia : Tick (/) off this column if you opt for Azizia category accommodation.

Exemption : If you opt for any exemption, write the name of the Rubat. Pilgrim who opt for Rubat he/she may also indicate a choice for any of the three categories accommodation viz., Green, White or Azizia till Rubat allotment is received.

Meeqat for Shia pilgrims : Shia pilgrims should tick the column of Johfa.

3. Details as per International Passport.

(valid International passport should be attached.)

Date of expiry : write the date of expiry.
Applicant : Surname : Write the surname as in the passport

Date of birth : Fill up the column in figure.

4. Name & relation of holder's nominee or legal representatives:-

(Particulars of the person declared as nominee in India who should be contacted in case of exigencies occurred in Saudi Arabia)

Full Name : Write the name of the person whom you wish to nominate in India and who should be contacted in case of exigencies occurred in Saudi Arabia.

Relationship : Write the relationship with nominee

Address : Write the address of the nominee

Signature/Thumb: Put the signature/thumb impression of nominee

5. Name of the Mehram with relationship (For female pilgrims only)

‘Mehram’ is either the husband or any other person with whom MARRIAGE CANNOT BE CONTRACTED because of blood relationship, or relationship by breast feeding or relationship through in-laws, under the Muslim Law. A lady pilgrim, irrespective of age and marital status, must have a ‘Mehram’ with her, while proceeding for Hajj. ‘Mehram’ should be an Adult male of sound mind. The details of Mehram are as follows:-

(1) Husband, (2) Father, (3) Son, (4) Brother, (5) Uncle – means blood related Father’s brother, mother’s brother, (6) Nephew – means blood related sister’s son & brother’s son, (7) Father-in-Law, (8) Son-in-Law, (9) Grand Father and (10) Grand son.

Name : Write the name of the mehram.

Relationship : Write the relationship of mehram

Signature/Thumb : Put the signature/thumb impression of mehram

6. Details required for refund if any.

Fill up the bank particulars in the appropriate column correctly for refund, if any.

7. Special requirement if any. : Write special requirement/request if any.

Signature/Thumb impression

CERTIFICATE OF PHYSICAL FITNESS:

This column should be filled up by the Registered Medical Practitioner with signature and seal in the column provided. Please furnish your BLOOD GROUP without fail. Please also record your blood pressure in case you are a B.P. patient. Please also tick the ailment columns, if you are suffering from any of such ailment.

SOLEMN DECLARATION BY THE APPLICANT:

This column should be filled by the applicant together with signature after reading this column. Write the name of the applicant, name of the father or

husband and full address and cover number at the appropriate place. Put your signature in the space provided.

UNDERTAKING:

Each applicant should give three undertakings mentioned in the application form for the following without which the application form for Hajj 2010 cannot be accepted:-

- (i) Non-Performance of Hajj during last five years viz., Block year 2006-2009.
- (ii) Declaration regarding carrying of prescribed standard size of bags during Hajj journey.
- (iii) Declaration regarding no objection, if the accommodation category is changed by CGI at the time of allotment in case of non-availability of accommodation in the category opted by you.

ATTESTATION CERTIFICATE: (Affix 3.5 x 3.5 cm latest colour passport size photograph having white background to be pasted in the column provided.)

The certificate is required to be signed by any one of the following persons:-

Member of Parliament, Member of Haj Committee of India, Member of Legislative Assembly, Member of State Hajj Committee, Municipal Councilor, Principal of recognised school, Member of District Board, Zilla Parishad of district of the applicant, District Collector, General Manager of Government Undertaking, Tahsildars, Gazetted Officer, Inspector incharge of Police Station, President or Sarpanch of Village Panchayat of the place of residence of the applicant, BDO, SDM.

The details of attesting authority to be filled up with name, designation, date and signature with their seal.

Note: If there is any infant in the group, then the details of application may be filled in the 'Infant Form' attached with this form. Not more than two infants below age of 2 years will be allowed.
